

**TOWN OF CROTHERSVILLE
ORDINANCE NO. 2011-
AN ORDINANCE AMENDING CHAPTER 71 OF THE CROTHERSVILLE CODE,
CONCERNING SPEED LIMITS**

WHEREAS, it is the duty of the Town of Crothersville Town Council to prescribe rules and regulations for the health, safety and welfare of Crothersville, Indiana;
NOW, THEREFORE, BE IT ORDAINED THAT Title 7, Chapter 71, Schedule I as it pertains to maximum speeds on town streets is hereby amended in its entirety and replaced with the following schedule:

(Crothersville Code §10.99)

PUBLIC NOTICE
TOWN OF CROTHERSVILLE
ORDINANCE NO. 2011-
AN ORDINANCE AMENDING CHAPTER 70 OF THE CROTHERSVILLE CODE,
CONCERNING SPEED LIMITS

WHEREAS, it is the duty of the Town of Crothersville Town Council to prescribe rules and regulations for the health, safety and welfare of Crothersville, Indiana;

NOW, THEREFORE, BE IT ORDAINED THAT the Crothersville, Indiana Code of Ordinance, Section § 70.10 is hereby amended to read as follows:

§ 70.10 (A)(2) Speed limit on streets. No person shall ride, drive, push, pull, tow, or otherwise propel any vehicle over and along the streets of the town at any place where there is no posted speed limit at a speed in excess of 30 miles per hour.

§ 70.10 (B) Speed limit on alleys. No person shall drive a motor vehicle upon the public alleys located within the town in excess of 15 miles per hour

NOW, THEREFORE, BE IT FURTHER ORDAINED THAT:

Penalty: Any person, firm, or corporation who violates any provision of this ordinance shall be subject to penalties as set forth in Crothersville Ordinances 2009-2 and 2009-3 or for which a penalty is not specifically provided shall, upon conviction, be subject to a fine not exceeding \$2,500.00.
